## COUNCIL MEETING

# MR. CONTIPELLI CALLED CAUCUS TO ORDER at 5:08 p.m.

MAYOR BACCI CALLED ROLL CALL: Bloam, Centa, Contipelli, Schoeffler, Unger, Volek.

Mr. Contipelli asked if there were any questions with the agenda.

Mr. Contipelli asked council to look at the numerous motions that were on the agenda and asked Law Director Chojnacki, if possible, can we make one motion to approve them all. Mr. Chojnacki responded that the purpose of reading them during caucus will make it so that during the council meeting they wouldn't have to read each one.

CFO Meriwether asked if council would consider adjusting the purchasing agents authority, thus the reason for the excessive amount of motions on the agenda. Law Director Chojnacki reminded council that the current threshold for purchases between \$5,000-\$25,000 needs finance committee approval and purchases \$25,000.01-\$50,000 needs a motion by council. What council can agree to is adjust the finance committee approval to be \$25,000-\$75,000; legislative approval to be \$75,000-\$150,000 with 3 quotes and competitive bidding will be anything above \$150,000. With council support a review will be done and a new policy and legislation will be coming in the future.

Mr. Contipelli asked if we were going to get the \$75,000 grant from the sewer district. Village Engineer Sciano responded that yes, the village will be getting the grant.

Mayor Bacci stated that Chief Sturgill provided the answers that Mr. Centa previously had concerning the streetlights. The mayor reminded council that depending on the location of the light poles, it can cause confusion on who is responsible for them – the village or the state.

Mayor Bacci asked if council had anyone in mind for the Charter Review. Mr. Schoeffler responded that he did, and Mr. Unger noted that he may have someone in mind. The mayor asked if they could please email his office the names of those they choose. Mr. Contipelli asked the mayor if council can pass legislation next year to prolong the Charter Review. Law Director Chojnacki stated that they can eliminate the review or prolong it to 10 years. Mr. Contipelli asked if they can pass legislation to eliminate it this year. Mr. Chojnacki stated that council can pass legislation to do so if they wanted. Mr. Contipelli told the Mayor that this is something to look into this year.

Mayor Bacci stated that since February 1, the village had officially acquired the Toscana Hall property and our service department has been cleaning up the area, landscaping, and taking down the signs—assuring council that there are plans to put up a new plaque to memorialize our heritage of our community. The disappointment of the care of the building is extremely

upsetting. Since the village has taken over, Service Director Sammons and Assistant Service Director Baciak and their crew have cleaned it up to an extent. Our fire department has been active at the property to make sure everything is up to code and Mr. Sagan from our service department has been tending to the HVAC. If council would like to tour the property, the mayor can make a plan to do so.

The building at 4911 Grant Avenue (formerly Alacriant) was recently sold to Specrete who have a total of 15 employees. The company manufacture additives which are designed and packaged specifically for underground construction applications, including piling, earth retention, high mobility grouting and tremie concrete. Currently, their facility is located at 10703 Quebec in Cleveland.

Howmet Aerospace will start negotiations this week with the United Autoworkers (UAW) representatives with the intent of bargaining in good faith to reach an agreement before the current contract ends. Howmet is committed to working with UAW to protect their customers, preserve jobs and support the long-term competitiveness of the Cleveland Operations.

Cuyahoga Heights School Superintendent Mr. Tom Evans, Board Member Mr. Mark Dobbins, along with members of the Best Committee were in attendance and spoke to council about how Ohio school districts are funded and about the upcoming levy. Superintendent Evans passed out a Cuyahoga Heights Local School District Levy Fact Sheet to all of council. *See Exhibit*.

Mr. Contipelli inquired about the update on the water department. Mayor Bacci responded that the first issue was fixed, and they energized the transmission line. Unfortunately, there was another leak north of that area on East 71<sup>st</sup> Street. Village Engineer Sciano informed council that the water department will be in the village once again, but they will open up the road and repair instead of using a laser.

Caucus ended at 5:55 p.m.
